### 1. INTRODUCTION

- 11 We at Eezy Group (hereinafter referred to as "Eezy Group" or the "Company") take our responsibilities under applicable data protection laws seriously. This policy aims to help you understand how we collect, use, disclose, and/or process the personal data you provide to us, as well as to assist you in making informed decisions before granting us access to your personal data.
- 12 This statement should be read together with our Terms and Conditions for products and services.
- 13 Personal data is information relating to our customer or potential customers (hereafter referred to "you" or "your")
- 14 The data controller of your personal data is the specific Eezy Group-affiliated company with which you have or may establish a relationship.
- 15 This statement applies to all customers, suppliers and all clients who have any business dealings with the company.

### 2. STATEMENT OF DETAILS

#### 21 Collection of Information

We collect your personal information with your knowledge and consent when you do anyof the following (please note that this list is not exhaustive):

- a) Apply for a specific product or service;
- b) Ask for more information about our product or service or contact us with a query or complaint;
- c) Respond to or participate in a survey, marketing promotion, prize competition or special offer;
- d) We may collect your information when you interact with us as a supplier as prescribed in this statement;
- e) We may also collect information when you visit any of our premises;
- f) When you interact with our sales agents, they may collect personal information;

## 22 What Information is collected

The information we collect and store about you includes but is not limited to the following:

- a) Your identity including your name, address, location, phone number, identity document type and number, date of birth, email address, age and gender.
- b) Payment Information (e.g., credit card details and Mpesa details).
- c) Vehicle Information (e.g., VIN, registration details, make, model, year, mileage, condition, color, fuel type, engine size).

- d) Your contact with us, such as when you call us or interact with us through social media (we may record your conversations, social media or other interactions with us).
- e) Vehicle log book information.
- f) Financial Details (e.g., income, credit history) for loan facilitation.
- g) User-Generated Content (e.g., listings, reviews, and comments).

### 23 Use of Information

We may use and analyze your information for the following purposes:

- a) Processing applications for products and services, facilitating payments and transactions, and fulfilling instructions or requests;
- b) Responding to any of your queries or concerns;
- c) Verifying your identity through publicly available and/or restricted government databases to comply with applicable regulatory requirements;
- d) Assessing your suitability for products and services;
- e) Keeping you informed about new products and services and contacting you regarding any new offerings, unless you opt out of receiving such marketing messages (you may opt out at any time by contacting the applicable Eezy Group Affiliated Companies or by sending "STOP" to the number provided in the SMS);
- f) Complying with legal, governmental, or regulatory requirements, or for use by our legal representatives in connection with any legal proceedings;
- g) Supporting business practices, including quality control, training, and ensuring the effective operation of our systems;
- h) To understand how you use our products and services for purposes of developing or improving products and services;
- i) Preventing and detecting fraud or other crimes and for debt recovery;
- j) For research, statistical, survey and other scientific or business purposes;
- k) Provide aggregated data (which do not contain any information which may identify you as an individual) to third parties for research and scientific purpose;
- l) Administer any of our online platforms/websites.

## **Lawful Basis for processing your information**

We will process your personal information based on any of the lawful basis provided for under the Data Protection Law:

- a) The performance of a Product/Service Agreement with you;
- b) Eezy Group legitimate business interests;
- c) Compliance with a mandatory legal obligation;
- d) Consent you provide;
- e) Public interest;
- f) Your vital interest.

### 25 Retention of Information

We retain your personal data in line with our legal and regulatory obligations and for business and operational purposes. In the majority of cases this will be for seven years from the end of your relationship with us.

Anonymized information that can no longer be associated with you may be held indefinitely.

## 3. DISCLOSURE OF INFORMATION

- 3.1 We will respect the confidentiality of the personal data you provide to us.
- 32 Any disclosure of your information shall be in accordance with applicable law and regulations. The company shall assess and review each application for information and may decline to grant such information to the requesting party.
- 33 We may disclose your information to:
  - a) Law-enforcement agencies, regulatory authorities, courts or other statutory authorities in response to a demand issued with the appropriate lawful mandate and where the form and scope of the demand is compliant with the law.
  - b) Our associates, partners, software developers or agents who are involved in delivering the company's products and services you order or use;
  - c) Fraud prevention and Anti money laundering agencies, credit-reference agencies;
  - d) Publicly available and/or restricted government databases to verify your identity information in order to comply with regulatory requirements;
  - e) Survey agencies that conduct surveys on behalf of the company;
  - f) Any other person that we deem legitimately necessary to share the data with.
- 34 We shall not release any information to any individual or entity that is acting beyond its legal mandate.

# 3.5 Marketing

- 3.5.1 We may use your personal data to conduct market research and surveys with the aim of improving our products and services and for marketing purposes, promotional events, competitions and lucky draws.
- 3.5.2 You can ask us to stop sending you marketing messages at any time by writing to us or by following the opt out option on any marketing message sent to you or by attending to us or contacting us at any time through the provided contacts.

### 4. ACCESS TO AND UPDATING YOUR INFORMATION

If you believe that our records contain inaccurate or incomplete information about you, please visit any of our branch outlets to make the necessary amendments. Some changes will only be made once the necessary supporting documentation has been obtained. We will take reasonable steps to investigate your concerns and correct inaccurate information in a timely manner.

# 5. SAFEGUARDING AND PROTECTION OF INFORMATION

The company has put in place technical and operational measures to ensure integrity and confidentiality of your data via controls around access control, physical and environmental security and monitoring and compliance.

## 6. YOUR RIGHTS

- Subject to legal and contractual exceptions, you have rights under data protection laws inrelation to your personal data. These are listed below: -
- a) Right to be informed that we are collecting personal data about you;
- b) Right to access personal data that we hold about you and request for information about how we process it;
- c) Right to request that we correct your personal data where it is inaccurate or incomplete;
- d) Right to request that we erase your personal data noting that we may continue to retain your information if obligated by the law or entitled to do so;
- e) Right to object and withdraw your consent to processing of your personal data. We may continue to process if we have a legitimate or legal reason to do so;
- Right to request restricted processing of your personal data noting that we may beentitled or legally obligated to continue processing your data and refuse your request;

- We may need to request specific information from you to help us confirm your identity andensure your right to access your personal data (or to exercise any of your other rights).
